### Attachment A

## Rules for Fuel Master System use:

- 1. Each user is assigned a key and will be responsible for all transactions made with that key.
- 2. If a key is lost, it is the responsibility of the user to notify the Department of Public Works immediately.
- 3. Each vehicle receiving fuel is assigned a key.
- 4. It is the responsibility of the municipality to notify the Department of Public Works when a user no longer has access to the system and return their key to the DPW.
- 5. It is the responsibility of the municipality to provide DPW with updated vehicle and user information.
- 6. Any time a user is unable to obtain fuel they must immediately report it to the DPW offices.
- 7. The municipality is responsible for all transactions made from their keys. Any questionable transactions will be the responsibility of the municipality.
- 8. Any spills of fuel or gas are to be reported immediately to the DPW office during working hours or the Sheriff's office during off hours.

### AGREEMENT FOR USE OF FUEL MASTER SYSTEM

THIS AGREEMENT made this 15 day of November ,20 10 by and between the County of Delaware (hereinafter called "County") acting by its Commissioner of Public Works (hereinafter referred to as "Commissioner") and the Town of Delhi (hereinafter called "Town/Village") acting by its Town Superintendent of Highways as follows:

WHEREAS, the New York State Comptroller's Office has recommended the County allow local municipalities and fire departments the use of their Fuel Master System; and

WHEREAS, the County has the capacity and staff to administer the system for local agencies.

NOW, THEREFORE, in consideration of the mutual covenants and agreements between the parties hereto, it is hereby agreed as follows:

#### The Town of Delhi shall:

- Pay to the Delaware County Department of Public Works a start up fee in the amount of \$5.00 per user and vehicle. This fee is to cover costs of entering the Town's data into the system, supplying keys for the vehicles and users, and invoicing.
- Pay to the County a fee of \$4.50 for any replacement keys or new keys after the initial set up.
- Follow all rules pertaining to the use of the system as outlined in Attachment A.
- Submit payment to the County within 30 days from receipt of any invoice.
- Provide the County, at least 30 days prior to the commencement of this agreement, the following information:
  - list of all users with required data
  - list of all vehicles with required data
- Following initial training, train all new personnel on the use of the system.
- If the Preventive Maintenance option is selected with on site key service, pay a \$25.00 monthly fee for reprogramming their vehicle keys. All keys will be reprogrammed at a specified time and date on a monthly basis.

#### The County shall:

- Provide the Town of Delhi with diesel and/or unleaded gas from the County's automated pumps.
- Submit an invoice monthly to the Town of Delhi.
- Charge fuel based on the previous month's average state bid price cost plus \$.10/gallon surcharge.
- Provide initial training to the Town of Delhi on using the system.

- Provide an optional Preventive Maintenance notification for the user. This program would give a message to the user when they vehicle they are fueling is overdue for maintenance. A County representative would be provided to re-program vehicle keys on a monthly basis at the fuel sites for all municipalities which opt for the preventative maintenance program with on site service. The municipality has the option to use the PM program but have their keys re-programmed in Delhi. If the Delhi option is selected it would be done at no cost to the municipality.

## The parties agree:

- The term of this agreement shall be for the term commencing with the execution of the agreement and shall have an initial term of one (1) year, or December 31, 2011 whichever comes first. Upon expiration of such initial term, this agreement shall be automatically renewed for successive one year terms; provided that either party hereto may terminate this agreement at any time with or without cause on thirty (30) days prior written notice to the other party.
- This agreement shall bind the successors, assigns and representatives of the parties hereto.
- The County will not be responsible for any problem occurring due to breakdown of the system. It will be the Town/Village's responsibility to obtain any necessary fuel if unable to use the system.
- The County reserves the right to increase the fees for keys with 30 days notice prior to the renewal of the contract on the first of January of each year.

IN WITNESS WHEREOF, this agreement has been executed by the County of Delaware acting by and through the Commissioner of Public Works and the Town of Delhi acting by and through the Highway Superintendent, on the day and year first above written.
