Supervisor Tuthill called the meeting to order at 3:00pm.

**New Business:**

Supervisor Tuthill announced that the Assessor's have requested the appointment of Arden Keller for the Board of Assessment Review. The current member would like to retire. The term of office would be retroactive from September 30, 2023 through September 30, 2028. A motion was made by Councilmember Baldwin to appoint Keller to the Board of Assessment Review per the above. Councilmember Cairns seconded the motion, motion carried.

Councilmember Cairns wished to state that it has been a pleasure being on the board. He does count it as a privilege to have been involved and to see what he could do for the town of Delhi. To the new board coming on he said don't always think taking the easy road is the way to go.
